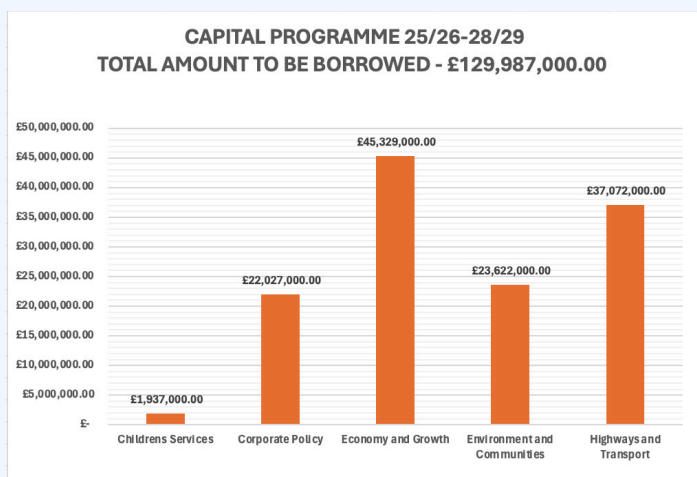

**THAT'S HOW MUCH MONEY THE COUNCIL ARE BORROWING FROM THE PRUDENTIAL TO FUND SOME OF THEIR PROJECTS OVER THE NEXT FOUR YEARS!**

## What does this mean?

According to the Capital Programme 2025/26 - 2028/29 the council intend to borrow just shy of £130 million to cover, in some cases entire committed projects.

The following graph is a representation of expected borrowing over 5 areas highlighting the total amount to be borrowed over each area.



The following is a breakdown of each area and only includes projects where borrowing has been identified.

Area	Total Expenditure	Total Borrowing	% of Borrowing
Children & Families	£4,551,000.00	£1,937,000.00	42.5%
Corporate Policy	£22,027,000.00	£22,027,000.00	100%
Economy & Growth	£92,584,000.00	£20,341,000.00	21.9%
Environment & Communities	£23,622,000.00	£23,622,000.00	100%
Highways & Transport	£152,591,000.00	£37,072,000.00	24.2%

One of the most concerning is 100% of all Corporate Policy projects, without exception, will need to be fully funded by borrowing!

These cover ICT Services and Finance and Customer Services!

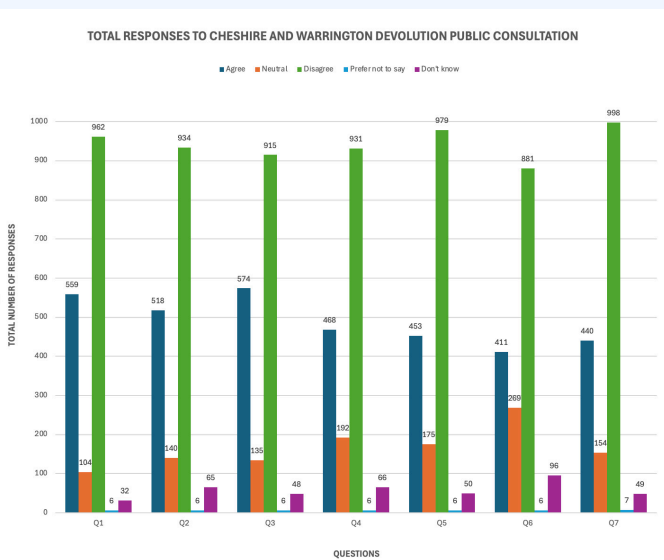

## DEVOLUTION UPDATE!

On the 17th July the Government finally released the data on the **CHESHIRE AND WARRINGTON DEVOLUTION CONSULTATION!**



**SURPRISE SURPRISE** the above graph clearly shows that once again the majority of those who responded disagreed with all questions yet the Government attempted to counter this negative response with their usual pacifying excuses!

The above figures provide a full breakdown of the total number of people who responded and their area of representation.

The Full Council will meet on September 17th to vote on whether they wish to proceed with devolution.

Cheshire West and Chester will have a final decision on 10th September and Warrington Borough Council will have their final decision on 22nd September.
