In Focus!

DID YOU KNOW?



The UK government is legislating to abolish the Committee system of local council governance in England, making the Leader and Cabinet model the standard for all councils!

What does this mean?

In a cabinet system, a small group of councillors, the "Cabinet," led by the council leader, makes significant decisions on behalf of the full council, rather than a large number of different committees.

Leader and cabinet model (most popular)

The full council elects a leader who, in turn, appoints and chairs the cabinet. Each cabinet member has a specific area of responsibility – for example regeneration, children and young people, housing or finance.

The cabinet meets regularly (normally weekly or fortnightly) so decisions are made quickly. The cabinet may also be called the executive.

Cheshire East Council currently operate a Committee system:

Committee system (less popular)

The council establishes a number of committees, each with a specific area of responsibility.

The political groups appoint elected members to the committees. More councillors are actively involved in decision-making, but it can take longer to reach decisions.

Councils not operating a committee system must establish overview and scrutiny arrangements through which non-cabinet councillors can scrutinise decisions.

In the Spotlight!



At the Full Council Extraordinary meeting held on 17th September councillors voted in favour of changing from a Committee system to a Cabinet and Leader form of governance, likely to come into effect in May 2026!

Considerations

While some advantages exist, such as streamlined decision-making, clear leadership and accountability and strong executive function, the system's effectiveness depends on the competence of the leader and cabinet, as well as checks and balances (e.g. scrutiny committees) to prevent over-centralisation. Critics argue it can sideline non-cabinet councillors or reduce public input compared to more participatory systems.

What Are The Disadvantages?

Disadvantages of a local cabinet governance structure include a democratic deficit, a lack of transparency, ineffective scrutiny, and a concentration of power. This model, where a small group of executive members makes most decisions, can **WEAKEN** the role of other elected councillors and hinder public accountability!

Overview of Disadvantages:

- **Marginilisation of non-executive members**
- **Weakened full council**
- **One-party dominance**
- **Opaque decision-making**
- **Limited Public Consultation**
- **Erosion of public trust**
- **Weak oversight powers**
- **Scrutiny disregarded**
- **Aggressive executive behaviour**
- **Overbearing leadership**
- **Poor decisions based on personal interest**
- **Officer manipulation.**

The absence of public engagement and the lack of media communication regarding this vital potential shift in the governance framework before it was addressed in the Full council meeting, alongside the aforementioned drawbacks, seem to signify a **SIGNIFICANT DECLINE IN DEMOCRATIC PRINCIPLES!**

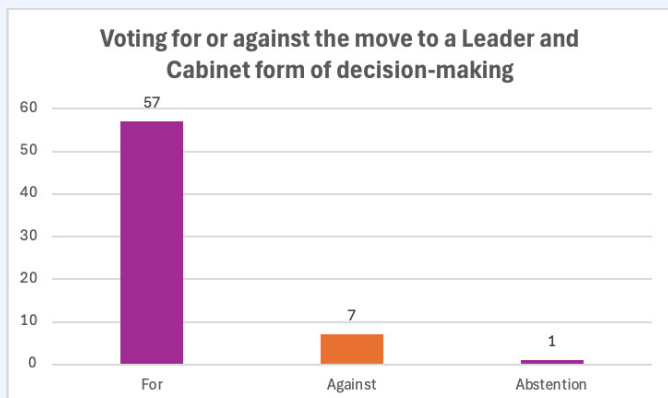
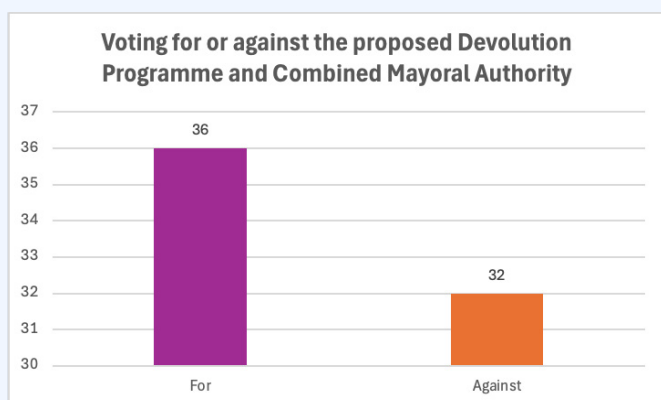

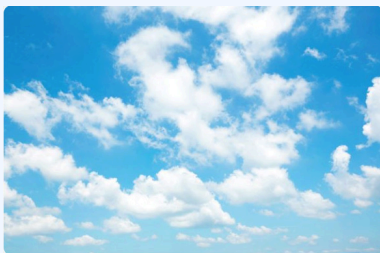
